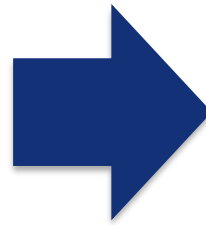

 - **351 beneficiaries**

- **Plus 79 new energy agencies** established (2003-2013)

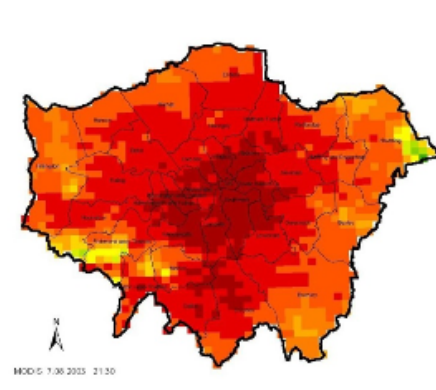

CELSIUS is leading the development of district heating in Europe

The cities of Gothenburg, London, Rotterdam, Genoa and Cologne have recruited 50 European cities to become members of the district heating and cooling project CELSIUS.



FOCUS ON

Setting up a local sustainable energy investment fund: Empowerment and a 'can-do' approach go a long way



Supported by Intelligent Energy Europe, the project Mobilising Local Energy Investment (MLEI) Cambridgeshire (L-CIF), which has been running since late 2012, aimed at testing the business case for a local Low Carbon Investment Fund by using public money and public sector projects to leverage private investment and develop a bankable pipeline of projects.

Support initiative to assist actors working on sustainable energy at the local and regional level (2017-2020)

- Master classes and peer-to-peer coaching to raise the skills of local and regional **energy agencies** in energy efficiency, financing and project development
- Energy agencies will enhance their role of project developers, aggregators and facilitators for public authorities

* First Master Class in Brussels by the end of 2017, so call for applications should start after summer

Sustainable Energy Investments Forums (2016-2019)

- Series of capacity-building and networking events at national and regional level in 15 Member States
- Objective: to trigger large-scale investment programmes and financing schemes
- E.g. 'Energy Efficiency Finance Market Place' event on 18-19 January 2017
